DAY CAMP & BOARDING TERMS & CONDITIONS

1. I specifically represent to Playfurlots that I am the legal owner of my dog. In addition, my dog is healthy, meets Playfurlots vaccination standards, and has not harmed or shown aggression and/or threatening behavior towards any person(s) or other dog(s) and has not been exposed to any known communicable disease within a 30-day period immediately prior to admission to day camp or boarding activities. I further represent that each time my dog is brought to Playfurlots, I will be recertifying that my dog is in good health and has not had any communicable illness of any kind for 30 days prior to admission. I further agree to inform Playfurlots of any changes in my dog's condition and/or behavior prior to any day camp or boarding visits.
2. I understand and agree that any problems with my dog, behavioral, medical or otherwise, will be treated as deemed best by staff of Playfurlots in their sole discretion, and in what they view as the best interest of the animal. I understand that I assume full financial responsibility and all liability for any and all expenses involved in regard to the behavior and health of my dog.
3. I understand that the owners, staff, and volunteers at Playfurlots will not be liable, financially, or otherwise for injuries to my dog, me, or any property of mine while my dog is participating in activities at the facility.
4. I expressly wave and relinquish any and all claims against Playfurlots its employees, staff, volunteers, and representatives for any injury, illness, or harm to my dog. Under no circumstances will Playfurlots be liable for consequential damages.
5. I understand that there are risks and benefits associated with group socialization of dogs. I agree that the benefits outweigh the risks and that I accept the risk. I desire a socialized environment for my dog while attending services provided by Playfurlots and while in their care. I understand that while the socialization and play is closely and carefully monitored by Playfurlots staff to prevent injury, it is still possible that during the course of normal play my dog may receive minor nicks and scratches from roughhousing with other dogs.
6. I understand that the leash-free environment at Playfurlots provides dogs the opportunity to play in close physical contact, including with their teeth and paws. I acknowledge that no amount of supervision or personalized care by Playfurlots, its employees, staff volunteer, and representatives, can prevent the possibility of injury or illness to my dog.
7. I understand that my dog must have flea and tick protection as recommended by my veterinarian. I further understand that Playfurlots will not be held liable if my dog contracts fleas or ticks while participating in activities at our facility, as it is my sole responsibility to work with my veterinarian on an effective treatment plan.



8. I understand that my dog is required to be fully vaccinated (including Distemper/Parvo, Leptospirosis, Bordetella, and Rabies). I acknowledge that I am required to provide documented proof of such vaccinations to Playfurlots. I further acknowledge that it is my responsibility to ensure that my dog continues to be fully vaccinated and that Playfurlots reserves the right to remove my dog from the facility in the event we become aware of an expired vaccine.
9. I hereby agree to allow Playfurlots to take photographs or video of my pet to use in print form or otherwise for publication and /or promotion or social media.
10. A minimum of 24-hours is required for day camp and boarding cancellations.
11. 24 Hours or more advance notice on daycare and boarding appointment is required.
12. I understand days, times and late fees as explained on the website and set forth below:
 - a. Operating hours are between 9:00 am and 5:00 pm Monday - Friday
 - b. Drop off time is between 9am and 11am by appointment only.
 - c. Late fees will be assessed at \$5 after the first 15 minutes and every 15 minutes thereafter.
 - d. Half-day clients staying longer than 5 hours will be charged a full day.
 - e. Boarding fees cover a 24-hour period from drop off. Any dogs staying additional time will be charged the appropriate day camp and/or boarding fee.
 - f. Times of drop off or pick up, sent by me in text, are set times. Any changes will resort in late fees.
13. I understand that Playfurlots reserves the right to refuse admittance to any dog that displays signs of untreated or potentially contagious conditions, demonstrates aggressive behavior, or who fails our standard health and temperament policies. I further understand and agree that any problems that develop with my dog will be treated as deemed appropriate by the staff of Playfurlots in their sole discretion.

MEDICAL RELEASE FORM

The safety and well-being of your pet(s) is of the highest importance. Insuring that your pet remains safe and well cared for is our first responsibility and as such we take it very seriously. We recommend our pet parents screen for pre-existing health conditions, but some factors may be beyond our control. In the event that a medical emergency arises while a pet is at our facility, or participating in a service that we provide it is imperative that we are immediately able to get them medical treatment at the closest available facility. We will call ahead to the veterinary offices in closest proximity geographically to us to insure they can handle the emergency present. We will then rush the animal to the closest available facility for treatment. We notify the owner after we have secured a medical treatment center to avoid any delays. Our goal is to get your pet medical attention as quickly as humanly possible, and any distractions may interfere with that process.

I understand in the event that Playfurlots, at its sole discretion, deems the need for immediate medical attention by a licensed veterinarian, I authorize recommended care to secure the emergency. I agree and understand that a Playfurlots employee, owner, or affiliate will transport my pet to the closest available emergency facility. I further agree that I am financially responsible for any medical treatment my pet(s) receives as a result of a medical emergency while attending services provided by Playfurlots.
